# Privacy and cookies policy

#### **GENERAL PROVISIONS**

#### **COOKIES**

Satoria Group S.A. pursuant to the provisions of Art. 173 and 174 of the Polish Act of 16 July 2004 Telecommunications Law (Journal of Laws dated. 16 July 2004, as amended.) inform, that the Services uses a technology called files "Cookies".

When you use the Services at your end device (PC, smartphone, tablet, etc.) are saved small files (particularly text) containing the information necessary for the proper use of the online store so-called cookies. By storing these files on the device's possible, among others, storing login information, so you will not have to enter each username and password, or adjust the content to your interests. Cookies are also used to collect statistical data the Service in order to fit the preferences of the Service Users.

These files are not harmful in any way for your device and do not modify its settings or settings software installed on it. Reading the contents of these files is possible only by the server that created them.

- Persistent cookies: they are stored on the device and remain there until you delete them.
   End of the session the browser or turning off the device does not delete them from your device.

## **GOALS COLLECTION OF COOKIES**

Information stored in cookies on your computer facilitate the user to use the Services. Cookies belonging to Satoria Group S.A. are used for the following purposes:

 Advertising (eg adaptation presented through the Services advertising services and products),
